PLANNED SCHEDULE

The general contractor mobilized to the site on Monday, July 24. They are currently in the process of setting up safety fencing on the perimeter of the work site, installing their erosion & sediment controls, setting up their field offices, and clearing the site.

The above activities are occurring in preparation for release of the Excavation, Sheeting & Shoring (ESS) permit, which will allow the excavation of the 2 story underground garage to commence. We anticipate the ESS permit will be issued the week of August 7, 2017.

Because of its' depth, the garage excavation requires a Support of Excavation system consisting of vertical steel piles and horizontal lagging boards. The steel piles will be driven into the ground with a pile driver, which is a large hammer like apparatus. Driving of the piles is a fairly loud process. We have scheduled the pile driving between the end of summer school and the beginning of the regular school year. We expect the pile driving to take approximately 4 weeks. We apologize in advance for the noise this activity will generate, it is probably the noisiest activity of any during construction. Thankfully, the duration of this activity is relatively short.
