

Acceptable Use Policies



Acceptable Use Policies (AUP)



An AUP outlines how a district "expects its community members to behave with technology" and may include:

- A statement of the vision, philosophy, or mission to frame the intent of the AUP
- Alignment with any existing code of conduct (ethical and legal responsibilities)
- Clear definitions of acceptable use and unacceptable use
- Shared ownership and responsibility
- Safety and privacy



Acceptable Use Policies



Specific topics may include:

- Use of Network
- Internet Safety (privacy, inappropriate content, unwanted contact)
- Filtering and Monitoring
- Copyright and Ownership of Work
- Network Security and Privacy (student data)
- Disciplinary Action
- Digital Citizenship
- Social Media Usage

Defining Policies and PIPs



Policy

- Principles of action
- Determined by the School Board
- Intended to shape decisions and actions
- Answers "what" and "why" questions
- Defines broad terms

Policy Implementation Procedures (PIPs)

- Procedural steps that APS follows to implement School Board policies
- Define management and operations of the school system in accordance with School Board policies
- Answer the "how", "who", and "when" questions
- Define specific operational terms


