## C. **PRESENTATION:** (7:32 PM)

Dr. Murphy introduced the Superintendent's FY 2018 Proposed Budget by reviewing the Arlington Public Schools 2015-16 Academic Highlights infographic which provides a glance of the success of APS and the collaboration that takes place across the school system. In addition, Dr. Murphy presented a video to showcase the five pillars that make up the whole child initiative. This initiative provides the foundation for the Superintendent's FY 2018 Proposed Budget, along with alignment to the APS Strategic Plan, Mission, Vision and the School Board's Budget Direction.

The total proposed budget for FY 2018 is \$617.0 million. Dr. Murphy presented information on the revenue, expenditures and distribution of funds of the school system. Additional expenditures in the FY 2018 Budget include Arlington Tech, staff compensation, increasing enrollment costs. New initiatives include instructional support, infrastructure support, and safety and security, resulting in a shortfall of \$14 million. Explaining this is a "needs-based" budget, Dr. Murphy then presented three tiers of reductions as options to balance the FY 2018 Proposed Budget.

To conclude, Dr. Murphy thanked the County Manager and County Board for their support of APS. He confirmed that the County Manager presented his Fiscal Year 2018 Proposed Budget to the County Board on February 23. As part of that proposed budget, the County Manager included consideration of a one cent tax rate increase to support the growing population of the school system.

Ms. Van Doren thanked Dr. Murphy, staff and the community for their support and feedback as the budget process moves forward. Ms. Van Doren called for a recess at 7:58 p.m. The Board reconvened in rooms 101 A/B at 8:11 PM.

Tameka Lovett-Miller, Budget Director Jorge Velasquez, Budget Analyst Budget Work Session #1 began by Ms. Peterson introducing staff and thanking them for their work in producing the Superintendent's FY 2018 Proposed Budget. She also stated that all material presented at the work session can be found online.

Ms. Peterson provided a summary of the revenue, expenditures and new investments presented in the Superintendent's FY 2018 Proposed Budget. She also reviewed the proposed reduction tiers, and agendas for upcoming work sessions. Ms. Peterson and Ms. Van Doren requested the Board to provide questions and suggested topics for future work sessions for more in-depth discussions.

Ms. Van Doren thanked the County Board for providing one-time funds and for their direction to the County Manger to include additional funding to benefit the schools. Ms. Van Doren reminded staff and the School Board that the County Manager's recommendation is under County Board consideration, and it is important to note that reductions in the APS budget will be necessary if the County does not fund the tax increase.

Ms. Peterson briefly reviewed the process for submitting and responding to School Board budget questions, adding that public feedback is accepted via the Engage at APS email address or online form.
