Thank you for serving on a School Task Group! Your objective is to help gather community input on the one-mile walk policy zone so APS transportation experts can develop final elementary school walk zones. Additionally, community members may need your help to find answers to questions.

School Task Group responsibilities are to:

- Gather community input about the school walk zone and identify possible areas of expansion
- Conduct neighborhood "walking tours" within the school's one-mile policy zone
- Share input with staff at two Task Group Work Sessions
- Inform community members about how they can participate in this process

During the time that the School Task Group works to gather community comments on expanding school walk zones (Feb. 20-March 20), residents can do any of the following:

- Review information, walk zone maps, community input and more at www.apsva.us/engage
- Share input on walk zones via an online questionnaire at www.apsva.us/elementary-school-boundary-change/ (please note deadlines differ for each school site—see pages 6-7)
- Observe a School Task Group Work Session (note: these sessions do not include a public comment period but attendees can provide written commentary and questions)
- Participate in a Neighborhood Walking Tour and provide input to the School Task Group using a printed questionnaire or the online version available on mobile phones
- Send questions and comments to engage@apsva.us

Also, residents can use an online questionnaire, Feb. 26-March 9, at www.apsva.us/elementary-school-boundary-change/, to share input on considerations for APS to take into account in reviewing elementary neighborhood and option school locations.

After the School Task Group completes its work and staff publishes draft recommendations on April 12 at www.apsva.us/elementary-school-boundary-change/, residents can do any of the following:

PLANNING NEIGHBORHOOD WALKING TOURS

Each School Task Group has at least two weeks to host one or more opportunities for residents to provide ideas for safe expansion of the walk zone within its school's one-mile policy zone. APS asks that all Task Group activities allow for broad participation and be done in a transparent manner.

Community Input Specifics

Among other questions posed on the walk zone questionnaire, APS transportation experts want to learn the following within the 1-mile policy zone to identify any potential areas of safe expansion:

- Streets that students are already crossing or that residents feel could be crossed by elementary students with the help of an added crossing guard, stop sign, etc.
- Ideas to help young pedestrians such as longer light times, traffic-calming measures, etc.
- Any obstructions or barriers to safe walking that APS can report to the County to address (e.g. broken sidewalk)

Neighborhood "Walking Tour" Ideas

- Consider distributing information during Parent-Teacher conference days on March 1-2
- Set up a table in front of the school to share materials and serve as a starting point
- Have a sign so people know what's taking place at your table
- People can take self-guided "tours" or can team up with a buddy to review the area
- People can provide input using information either in print or online:
 - Use printed map and questionnaire to walk around, fill out and return to group
 - Complete a questionnaire based on personal experiences and memory

Neighborhood "Walking Tour" Guidelines

- Task Groups can choose to hold more than one "walking tour" opportunity
- Activities should be held during daylight hours, with at least one during typical non-working hours such as a weekend
- Consider whether it is helpful to ask a Spanish-speaking community member to be present
- Please provide maps and explain that the questionnaire can be done online or in print
- Safety is paramount during any Task Group activity

PROMOTING NEIGHBORHOOD WALKING TOURS

There are many ways to promote walking tours! Below is sample content in English and Spanish that you can tailor with your group's specifics for use on PTA and Civic Association websites and in email distributions, Facebook posts, tweets, and text messages. Write your own, too!

Sample News Item for Website or Email

APS needs the community's help with a planning initiative that will create attendance zones for new elementary schools, review the locations of elementary neighborhood and option schools, and adjust elementary school boundaries. Please help APS review elementary school walk zones and identify possible areas where these may be safely expanded so that more students can walk to school.
