Paul Jamelske, Director of Special Education	The Dept of Special Education and-Student Services and Special Education has merged with the Dept of Intruction and is now called Dept. of Teaching and Learning. They developed mission and vision statement. Our Mission: To ignite a passion for learning with equitable access and multiple pathways where learners connect, create, and innovate Our Vision: All individuals strive for their best as learners and global citizens Inclusion is a focus of School Board this year, as result of dedicated work of parents collaborating with school staff. Policy discussion will begin in the next few months. Discussion Period about ASEAC Report to ACI

ASEAC report to APS Advisory Council on Instruction (ACI) lead by Wendy Pizer ASEAC is technically under the structure of ACI. Report is due October 19, earlier than we thought. ASEAC report will be presented to ACI orally on November 1 by Paul P.

ACI will prioritize recommendations based on the School Board 2017-18 priorities and ACI priorities which include:

- Inclusion
- Literacy
- Opportunity Gaps
- Pre-K through 12 Instructional Vision
- The Whole Child

The following three recommendations recs that rose to the top were:

- Training (with a possible priority on training for General Education teachers)
- Co-taught Classrooms
- Accountability

Connections were noted between the following areas:

- Training of general education teachers and co-taught classrooms (possibly be combine into one rec.)
- Training of general education teachers and inclusion
- Accountability and clear written standards

<u>Discussion on Co-taught Classrooms:</u>

Cloe - her kid had all co-taught classrooms last year and it went very well. What is happening on this already county-wide?
Paul J.: varies from school to school. Principal crafts master schedule. Staffing allocations for specific areas, gen ed and special ed teacher staffing. Special ed staffing is driven by numbers of SWD and sometimes by service hours and disability type.
Rebecca -- huge budgetary implications, no accountability

Tauna -- putting cart before the horse, not necessarily best practices, really depends on how it is implemented. Would not support this as an ASEAC recommendation right now.

Discussion on Training:

Aides? Training gened teachers with special ed training? - have all their trainings together?

David Rosenblatt: UDL?

Jennifer Johnson: Preschool inclusion? Disability awareness for

students without disabilities?

Caitlin Davies: we have tons of training for sped. Problem with gen ed teachers is encouraging them to go. Maybe require a minimum number of hours on certain topics, or incentives -- change a policy on this rather than requiring certain trainings?

Maybe head toward a coaching model of training? Teachers really appreciate flexibility and choice in training Wendy: A teacher who has a cluster of gifted kids in their class is required to get 30 hours of gifted training every year, but nothing equivalent for students with disabilities

Keith: Can we encourage principals to establish master planning schedule to schedule in planning time?

Wendy: Special ed teachers used to support general ed teachers

Margy will draft report with help from committee.
