A. CALL TO ORDER AND CONVENE IN CLOSED MEETING:

Mr. Goldstein moved that the Board immediately convene in a closed meeting to consider the appointment of Director of Counseling at the Arlington Career Center and to discuss the assignment of two employees, as authorized by Virginia Code §2.2-3711(A)(1), seconded by Ms. Talento.
