


PreK-12 Instructional Program Pathways (IPP)

What is the IPP?

Our educators are working to develop a vision for Teaching and Learning that aligns with the Strategic Plan and Profile of a Virginia Graduate, defines the elements of APS options, supports access for all students, and guides decisions about our balance of options and neighborhood schools as APS grows to 34,000+ students. The IPP will provide a systemic framework for options and neighborhood schools that will align future instructional, capital and planning initiatives. It will serve as a guide when APS proposes new school facilities or undertakes a boundary process.



What Work has been Completed?

The IPP framework is still being developed. The working draft has been informed by staff from schools and APS departments, as well as school community representatives. APS is now gathering broad community input.

Working Draft Definition of "Options"

The definition of "options" will assist APS in selecting specific instructional models that fit within the PreK-12 IPP framework. The following working draft definition was written through a process led by instructional staff using input from other APS departments and community representatives.

All APS students are taught the same core curriculum. APS educational options offer specific and distinct, evidence-based learning models for all Arlington residents based on capacity and specific criteria.

Options may also include:

- A unique philosophy,
- Staff with specific training, and/or
- Recognition by an outside agency.
