By mutual agreement, Contract No. 73FY16 is hereby amended as follows:

Remove paragraph 6. CONTRACT TERM from EXHIBIT E - General Terms and Conditions to Contract 73FY16 and replace with the following:

CONTRACT TERM

Time is of the essence. The Contract Term shall commence on the date the Purchasing Agent fully executes the Contract and shall terminate on June 30, 2019. The Contract may be renewed, one year at a time, by APS in its sole discretion at any time prior to thirty (30) days following expiration of the latest Contract Term, and such Renewal Contract Term shall be effective immediately upon expiration of the latest prior Contract Term. APS shall have this right of renewal for up to but not more than four (4) Renewal Contract Terms, making a maximum of five (5) Contract Terms.

Contract No. 73FY16 is hereby renewed for one (1) year. The renewal shall be effective from July 1, 2019, and shall remain valid through June 30, 2020. Additionally, Exhibit C - Fee Schedule is revised as shown herein. The revised Exhibit C - Fee Schedule is attached. All other terms and conditions shall remain unchanged.
