Closed Meeting and Work Session March 31, 2016

The Arlington School Board convened on Thursday, March 31, 2016, at 7:02 PM at 1426 North Quincy Street, Arlington, Virginia.

A. WORK SESSION

Mr. Gibson provided a brief overview of his experience with structure and organizational analysis. Board members confirmed they were supportive of exploring a process to help prepare for the anticipated growth in Arlington Public Schools in the next several years. This process will encompass several factors, including the growing enrollment, changes needed to respond to new laws, and expanding the types of programs offered to students. Mr. Gibson suggested that this process examine the topics such as span of control, alignment of functions, the organizational structure, and the use of the Superintendent's time, both internally and externally. Dr. Murphy noted the importance of this work aligning with the primary goal of APS which is instruction.

The group acknowledged that this planning process is at the concept stage, and shared some thoughts on information that would help guide the Board's consideration of how to proceed. Board members were interested in seeing how other high performing systems operate, including how Boards function, to help inform this discussion. The group also recognized that some aspects of the work ahead are more urgent and will need to be addressed first. Dr. Murphy summarized the discussion as an opportunity to begin this conversation, and it was agreed that Mr. Gibson will develop some options for next steps to be shared with the Board for consideration.

B. CONVENE IN CLOSED MEETING

Dr. Violand-Sánchez moved that the Board immediately convene in a closed meeting to consider recipients of the Honored Citizen awards, as authorized by Virginia Code §2.2-3711(A)(10), seconded by Ms. Van Doren. The motion was adopted in a vote of 5 - 0, with Mr. Goldstein, Dr. Kanninen, Ms. Van Doren and Dr. Violand-Sánchez voting affirmatively, and the Board convened in a closed meeting. Mr. Lander was not present at the vote.

The closed meeting adjourned at 8:25 PM and the Board reconvened in an open meeting.

C. CERTIFY CLOSED MEETING
