Non-negotiables

- Maintaining access to PreK programs for the students who most need them

Impacts

- Majority of McKinley student population reassigned to Reed
- ASFS boundary extends West, impacting the Ashlawn boundary
- Moving (some) PreK programs from North Arlington to Central or South Arlington

Secondary goals

- Increase access to ES option programs
- Fidelity to the 50/50 immersion model by locating program closer to more native-Spanish speakers
- Increase building utilization

Does moving a program closer to native speakers make up for removing a n'hood school?
