EDUCATIONAL RIGHTS FOR CHILDREN AND YOUTH LACKING FIXED, REGULAR AND ADEQUATE HOUSING

The McKinney-Vento Homeless Assistance Act guarantees school enrollment for anyone who, due to a lack of permanent housing, lives in inadequate or temporary settings, such as:

- Emergency shelters or transitional housing
- Motels, hotels, or campgrounds due to lack of an adequate alternative
- Cars, parks, public places, bus or train stations, or abandoned buildings
- Doubled up with relatives or friends due to loss of housing or economic hardship.

Children and youth experiencing homelessness have **a right to attend school**, even if their school records are not immediately available.

Children experiencing homelessness can stay in their school of origin or enroll in the public school where they live, according to their best interest.

Homeless unaccompanied youth have these same rights.



WHAT CAN PARENTS DO?



- Talk to the school social worker, principal, counselor, teacher, or school nurse about your housing situation.
- Inform the school when your family or child moves and give them the new address.
- Ask about services available to help your child.
- Seek information about the school close to where you live.
- When possible, bring birth certificates and school and immunization records when you enroll your child in school.
- Ask where you can get school supplies.
- Ask that records be transferred from your child's previous school.
- Arlington Public Schools is committed to providing support for students experiencing homelessness.

WHAT CAN PROJECT EXTRA STEP DO?

- Help parents enroll children in school.
- Help parents arrange transportation to keep students in their school of origin.
- Help enroll students in breakfast and lunch programs at school.
- Provide free tutoring services to students.
- Help provide school supplies and materials as needed.
- Help access APS Extended Day.
- Help families find community resources.
- Help students make a smooth transition between schools.
- Help process health and school records.
- Help educate the community about the needs of students who are experiencing homelessness under the McKinney-Vento Homeless Assistance Act.
