C. INTERIM SUPERINTENDENT'S PROPOSED FY2021 BUDGET:

Ms. Johnson began the presentation by confirming that the focus of all decisions is on honoring the APS commitment to every student and staff member. Thanking staff, including the Budget and Finance Department, Executive Leadership Team, and principals, for their work, she also acknowledged County and community support. Confirming the proposal is for a needs-based budget, she reviewed the School Board's adopted budget direction. She then confirmed that the proposed budget supports current initiatives as well as the recommendations and requirements from the program evaluations for English Learners and Students with special needs, and the recent DOJ settlement. Recognizing funding challenges, she confirmed the proposal is for a conservative, needs-based budget.

After reviewing external budget factors such as an increase in the retirement system contribution rate, state-mandated student-to-school-counselor ratios, and the need to provide competitive teacher salary scales, Ms. Johnson then highlighted county manager's proposed budget. She outlined rising costs that APS faces, such as enrollment increases, capacity issues, and rising costs for several operating items. Ms. Johnson then presented budget highlights, including the cost for enrollment growth, compensation, instructional supports, funds to support the operational infrastructure, and funding for continuing initiatives. She confirmed a gap of \$27.5 million between the proposed budget and the anticipated county transfer.

Ms. Johnson next highlighted steps taken to reduce the budget deficit, such as incorporating efficiencies in baseline budgets, using funds from reserves for one-time costs, and reallocating FLES funding to more urgent needs. She then presented tiered options to be considered to address a budget deficit if needed. She also reviewed the expenditure summary for all funds, the distribution of funds, and the revenue summary for all funds. In closing, Ms. Johnson shared key takeaways and reviewed the budget calendar.

Ms. Talento thanked Ms. Johnson and her staff for preparing the proposed budget.
