- 1. Welcome and Introductions
 - a. 2. Public Comment

- a. Josh Folb, Arlington Education Association: AEA is looking forward to the budget coming out and has been advocating for a "budget of needs"
 - i. The County-APS revenue sharing agreement provides for a lower percentage of budget funds for Arlington versus other nearby jurisdictions
 - ii. AEA is hoping the APS Board will push forward a needs-based budget (which supports higher compensation), even if it exceeds what the County is expecting
- 3. Destination 2027: Education's Contribution The BAC received a presentation by Abby Raphael, Co-Chair
 - a. Initiative of the Public Health Department they are required to put together a comprehensive plan every 10 years
 - b. A wide steering committee met for a year to put together the report
 - Key fundamentals: Data, Awareness, Collaboration and Access to Resources
 - ii. Have since been collaborating with the various equity organizations around Arlington, and meeting with advisory groups
 - c. Report results
 - i. A 10-year difference in life expectancy in Arlington based on who you are and where you live
 - ii. Community conditions impact performance and outcomes
 - iii. Disparities in discipline
 - iv. Variations in school subject scores across different race/ethnicity groups
 - v. Certain Arlington neighborhoods have 5x more child poverty than others
 - d. Arlington County Equity Resolution requires each department to apply an equity approach to the budget process
 - e. For APS how to embed equity in all areas: budget, CIP, boundaries, policies, student success, partnerships
 - i. Who benefits?
 - ii. Who is burdened?
 - iii. Who is missing?
 - iv. How do we know/what data do we have?
 - f. Recommended a hire at County level and APS level to focus on Equity, as well as a permanent team
 - i. County has not yet put together a position for this

- g. Many opportunities for the County and APS to work together on these initiatives
- 4. Equity Initiatives Arron Gregory, APS Chief Diversity, Equity and Inclusion Officer
 - a. Arron has been in the role for about 2 weeks he's talking to people, listening and soliciting information from people to help him learn and get up to speed
 - b. Equity needs to be a framework to drive priorities
 - c. He believes it has been taking school systems about 3 years to come up with a useful equity policy
 - i. Reviewing the work already done
 - ii. Use a team to assist him with this
 - d. System of schools versus a school system
 - i. Principals have a lot of individual control within their school
 - ii. Community around the school strongly drives the expectations
 - iii. PTA budgets vary widely
 - e. Budget tradeoffs should be compared against the APS strategic plan
 - i. If a goal is to close the achievement gap, is APS able to produce results and data that achieve this if we invest additional money in this area?
 - ii. What is the necessary investment (in time, resources and dollars) to allow something to be successful?
 - 1. Typically 3 to 5 years is the national trend
