# C. SUPERINTENDENT'S PROPOSED FY 2022 BUDGET:

Dr. Durán presented his proposed FY 2022 Budget, confirming that it is a needs-based budget and carefully considers the economic impact of the COVID-19 pandemic. He thanked the executive leadership team and staff for their work in producing the budget. He also thanked County Board members for their collaboration and partnership during a most difficult and unprecedented time. He explained that the proposed budget aligned with the APS Strategic Plan, Core Values, Mission and School Board Budget Direction focusing on student success.

Dr. Durán then explained that the proposed FY 2022 Budget totals \$704.4 million in expenditures, with a deficit of \$42.5 million. The proposed budget focuses on compensation, supporting education and equity, enrollment, funding for services for students with disabilities, resources for English learners, instructional and mental health support, financing for infrastructure and technology, and continued investments to support student growth. Dr. Durán also presented proposed tiered reductions that may need to be considered should APS not receive full funding to close the budget gap.

Ms. O'Grady thanked Dr. Durán and his staff for their work in preparing the proposed budget.

The School Board discussed budget reserves, staff compensation, tiered reductions, and proposed reductions from previous years. The Board expressed that more in-depth budget discussions will take place once Board members take the time to analyze the proposed budget.
