The Arlington School Board convened on Thursday, February 11, 2021 at 5:16 PM. This meeting was held by electronic communications due to the COVID-19 Pandemic, using Microsoft Teams.

Ms. O’Grady called the meeting to order at 5:16 PM. *Ms. O’Grady moved that the Board immediately convene in a closed meeting to consider 7 appointments, 4 changes in position/salary, 1 reclassification request, 5 resignations, and 3 retirement as authorized by Virginia Code §2.2-3711(A)(1).* The motion was seconded by Mr. Priddy.

*Dr. Kanninen moved to amend the motion to add one appointment so that the motion reads: 8 appointments, 4 changes in position/salary, 1 reclassification request, 5 resignations and 3 retirements.* The motion to amend was seconded by Mr. Priddy was adopted in a vote of 5 – 0. *Ms. O’Grady moved that the Board approve the motion as amended as follows: I move to immediately convene in a closed meeting to consider 8 appointments, 4 changes in position/salary, 1 reclassification request, 5 resignations and 3 retirements as authorized by Virginia Code §2.2-3711(A)(1)* seconded by Ms. Diaz-Torres.
