- 1. Proposed Updates and Revisions to School Board Policies: L-3 Charter Schools
 - Mr. Stockton presented the revisions to School Board Policy L-3 Charter Schools to add a process for the appeal of denial of a charter school in compliance with the Code of Virginia. He also reviewed the community engagement process to receive feedback.
- 2. Proposed Updates and Revisions to School Board Policies: I-7.2.5.30 Prevention, Intervention and Remediation, I-7.2.5.32 Summer Learning Opportunities, I-7.4.1.30 Extended Learning Opportunities
 - Ms. Terri Murphy, Director of the English Learners Office, presented the proposed revisions to I-7.2.5.30 Prevention, Intervention and Remediation to better align it with the Virginia Code and the Arlington Tiered System of Support. The revisions to I-7.2.5.32 Summer Learning Opportunities also included language to provide better alignment with Virginia Code. Revisions referenced the organizational structure within Arlington Public Schools responsible for the implementation of summer school programs and added specific references to related policies, including School Board Policy D-15 External Funding Commercial Activities, which outlines associated fees. Lastly, she recommended the retirement of I-7.4.1.30 Extended Learning Opportunities.
