



Dear Parent/Guardian of Current Gr. 8 students at Gunston & Jefferson:

APS is conducting a boundary adjustment process for Fall 2021 that is limited in scope, focusing on schools where enrollment currently exceeds capacity and/or enrollment exceeded capacity for the prior two school years, and a nearby school has capacity to accommodate additional students.

This letter is intended for families of students currently in 8th grade who attend Gunston or Jefferson and reside in one of the planning units that is proposed for reassignment. A separate letter will be sent to students currently in grades 9-11.

APS is proposing to reassign the following [planning units](#) from Wakefield High School to Washington-Liberty High School: 46110, 46120, 46111, 48160, 48180, 48290, 46140, 48150, 48280, 48281. The change will be effective for the start of the 2022-23 school year. **The boundary proposal applies to all current 8th grade students and all new and future incoming students.** Please note that current 8th grade students enrolled in the Immersion program may continue with that program at Wakefield and are not impacted by this change. Students attending Wakefield who are currently in grades 9-11 can also remain at Wakefield or may attend Washington-Liberty (newly assigned neighborhood high school) beginning in the 2022-23 school year.

We are contacting you now for the following reasons:

- Inform you of the proposed changes;
- Share the upcoming engagement schedule that will provide an opportunity to learn more about the proposal and ask questions;
- Share the timeline for the School Board decision; and
- Ask you to complete a letter of intent form. An email with a link will be sent separately and paper copies are available in the Gunston and Jefferson main office.

The purpose of the letter of intent form is to confirm that you have received information about this proposed boundary adjustment and to acknowledge that your current grade 8 student is proposed for reassignment to Washington-Liberty High School at the start of the 2022-23 school year.

Grandfathering Eligibility, New Students, Siblings, and Transportation Information

- **Grandfathering:** APS staff are proposing a grandfathering provision that allows students attending Wakefield who are currently in grades 9-11 to remain at Wakefield through completion of 12th grade or attend their newly assigned neighborhood school (Washington-Liberty) beginning in the 2022-23 school year.
- **New Students:** Any student who resides in one of the affected planning units and enrolls in APS following June 17, 2022 would attend Washington-Liberty High School.
- **Siblings:** Younger siblings of current grade 9-11 students at Wakefield, who reside in one of the planning units proposed for reassignment, are not eligible for grandfathering under this proposal and would attend Washington-Liberty (newly assigned neighborhood school) when they matriculate to high school.

- **Transportation:** APS transportation will be provided to the current 8th grade students as they matriculate to Washington-Liberty at the start of the 2022-23 school year and will continue to be provided to grade 9-11 students in these planning units whether they remain at Wakefield or choose to attend Washington-Liberty (newly assigned neighborhood school). The current grade 9-11 students in these planning units who remain at Wakefield would be provided transportation via [hub stops](#).
