#### A. CALL TO ORDER AND CLOSED MEETING

Dr. Kanninen called the meeting to order and moved that the Board immediately convene in a closed meeting to discuss the performance of a public school employee, as authorized by Virginia Code §2.2-3711(A)(1), seconded by Ms. O'Grady. The motion was adopted in a vote 5-0, with Ms. Diaz-Torres, Mr. Goldstein, Dr. Kanninen, Ms. O'Grady, and Mr. Priddy voting affirmatively.

Dr. Kanninen moved to certify that to the best of her knowledge, only public business matters lawfully exempted from open meeting requirements by Virginia law were discussed in the closed meeting, and only such public business matters as were identified in the motion convening the closed meeting were heard, discussed, or considered. Ms. Diaz-Torres expressed her excitement on recognizing the amazing accomplishments of the students in honor of Hispanic Heritage Month and Mr. Goldstein shared about activities taking place at his liaison schools.

### 2. Superintendent's Announcements and Updates

Dr. Durán also acknowledged the students that were recognized for Hispanic Heritage Month and expressed his gratitude for the opportunity to learn about the students. He provided an update on the official student enrollment for September 30 and important school year events. Dr. Durán shared that October was National Principal Appreciation Month, Bullying Prevention Month, and Learning Disabilities Awareness Month and he spoke about School Lunch Week. He then provided an update on the Fall 2021 Boundary Process and Adjustment of Elementary Immersion Feeder Schools highlighting that this boundary process was limited in scope, focusing on refinements to provide capacity relief where needed in 2022-23, and describing the engagement process. To end, Dr. Durán announced that U.S. News & World Report ranked APS elementary and middle schools top in the state and congratulated the winner of the state PTA Reflections Art Contest.

Mr. Goldstein inquired about the outreach to inform families of the community meetings related to the Fall 2021 Boundary Process and Ms. O'Grady encouraged families to write to APS Engage with questions about the process.

## F. MONITORING ITEMS (8:33 PM):

#### 1. APS Responses to Student Behaviors

Dr. Jeannette Allen, Director of Administrative Services, presented the APS philosophy regarding student behavior and noted that responses to student behavior shall be consistent with the mission, vision, and strategic principles of Arlington Public Schools and its commitment to equity, diversity, and inclusion. Responses shall also consider the student's social-emotional development, age, cultural background, and other relevant factors. She spoke about the alignment with the Strategic Plan objective 10, presented data related to the risk-ratio and disproportionality in suspension rates by race and ethnicity, and shared revisions to School Board policies addressing student behavior. In addition, she provided information on the new Student Code of Conduct Handbook and explained the supports in place to reduce disproportionality of student suspension and implement restorative justice practices.

The Board discussed the pivotal changes to address the challenges related to student behavior as part of a multiyear comprehensive plan, clarification on professional development, and the need to educate families and students about the restorative justice practices, student handbook, and the policies governing student behavior. They also conversed about the impact of strategies. In addition, the Board expressed their interest in reviewing future data to analyze meeting the objectives of the Strategic Plan and disproportionality risk ratio.

#### 2. Virtual Learning Program Update

Ms. Graves presented enrollment and demographic data, the online learning participation dashboard for each level, and she shared an update on staffing. In addition, Ms. Graves spoke about supporting the social and emotional needs of students and families and improving communication channels. Ms. Loft presented about the opportunities for professional development for staff. She also spoke about the services available to students as part of their school of record and the supports in place for students with disabilities.

The Board discussed filling vacancies, addressing the different student needs to ensure a consistent service across the system, and the future of the Virtual Learning Program. Highlighting the monumental effort put forth by staff to implement the virtual program, Ms. Diaz-Torres noted the need to address equity and the challenges with synchronous instruction. The Board requested receiving formal updates on the Virtual Learning Program and the progress to address learning loss.

Mr. John Mickevice, Internal Auditor, presented updates to the Proposed 2021-2022 Internal Audit Projects as a result of the Audit Committee meeting held on October 7, 2021.

Mr. Goldstein moved that the Board adopt the 2021-2022 School Year Internal Audit Annual Plan, seconded by Mr. Priddy.

#### 3. The Heights Building Phase 2 Architecture/Engineering Services

Mr. Chambers, Director, Design and Construction, confirmed the architecture and engineering fee of \$952,359 for VMDO Architects.

Ms. O'Grady moved that the Board approve the architecture and engineering team fee of \$952,359 for VMDO Architects for The Heights Building Phase 2, seconded by Ms. Diaz-Torres.

## H. INFORMATION ITEMS (10:10 PM):

## 1. Amazon "Think Big Space" at Wakefield High School

Mr. Stockton presented about the new Amazon Think Big Space at Wakefield High School, a unique collaboration between Amazon, Arlington Public Schools, and private community sponsors, to provide a dedicated space to support the division-wide STEM curriculum. He shared about the external funding from Ralph Johnson in the amount of \$109,000 and Amazon in the amount of \$150,000 to build the Think Big Space aimed to prioritize personalized learning to engage students of all ages, interests, and abilities. Mr. Brian Stout, Amazon Senior Manager of Public Policy, shared that Amazon Think Big Space was named after one of Amazon's 14 Leadership Principles which states "Thinking small is a self-fulfilling prophecy. Leaders create and communicate a bold direction that inspires results. They think differently and look around corners for ways to serve customers." Mr. Chris Willmore, Principal at Wakefield High School, thanked Amazon for partnering with Wakefield High School to build the first Think Big Space in a high school in the Americas, and Mr. Kris Martini, Director of Career, Technical, and Adult Education, spoke about the connection of the Think Big Space and the U.S. Department of Education's STEM 2026 Vision.

The Board briefly discussed the innovative opportunities that will be available for students to broaden their skills and engage in project-based learning.

#### 2. School Board Direction on the Superintendent's Proposed FY2023-32 Capital Improvement Plan (CIP)

Dr. Mayo provided an overview of the FY 2022-24 CIP Projects and the long-term projects that will continue in the FY 2023-32 CIP. He provided a summary of the financial considerations related to bond capacity. Mr. Chambers summarized the results of the Arlington Career Center Study and presented the four site plan options to accommodate the educational specifications of the site, noting that option four was the Superintendent's recommendation. Ms. Cathy Lin, Director of Facilities and Operations, shared the recommendations for a long-range plan to renovate existing school facilities. Lastly, Ms. Lisa Stengle, Executive Director of Planning and Evaluation, reviewed the recommended CIP direction that included funding for continued projects, prioritizing the renovations of facilities, and beginning the concept design for the Career Center.

The Board discussed the proposed options for the Career Center and the preliminary information on revenue.

# I. NEW BUSINESS:

Mr. Goldstein announced that in lieu of presenting a motion related to the Fall 2021 Boundary Process and Adjustment of Elementary Immersion Feeder Schools to gather additional information to inform his vote, he was going to submit questions to the Superintendent for follow-up.
