## Primary Preferences and Challenges to Navigate

- Standardizing/reducing eight bell schedules down to fewer, three, if possible
- Least amount of disruption to current schedules
- Maintaining 30-minute ride times for neighborhood schools; 60 minutes max for countywide programs
- Peak traffic congestion between 7:30-8:30 AM
- Infrastructure congestion with bus and parent traffic; shared bus loops
- Where possible, limiting dependence on cabs and contractors

## Survey Data

To garner feedback from parents, students, and staff about potential changes in bell times for schools, Arlington Public Schools created a series of surveys (parent, student and staff) regarding proposed changes to the bell schedule for the 2022-2023 academic year.

- Maintaining the current bell schedule was the most favored response.
- None of the proposed scenarios garnered the support of the majority of any of the three constituent groups.
- There was uneven representation in the responses to the survey. This was true across:
- School settings
- Student grade levels, and
- Responses by constituent group on individual questions.
- Parents, staff and students easily identified potential benefits and challenges to changes in the schedule.
- It is also clear that the different constituent groups perceived the complexity of the trade-offs both for individual students and between student groups (e.g. elementary vs. secondary)


## Survey Highlights

## Response Rates

- There were 6192 respondents, in total, to the surveys.
- Of these, slightly over half (3394 or 54.8\%) of the respondents identified themselves as parents of students within Arlington Public Schools.
- The second largest group of respondents (1565) identified as APS staff members.

## Arlington <br> Public <br> Schools <br> Survey Highlights

- There were responses from 46 school or work site.
- Over half ( $53.4 \%$ ) of the responses came from 10 sites:
- Gunston Middle
- Wakefield High
- Swanson Middle
- Yorktown Middle
- Dorothy Hamm Middle
- Washington-Liberty High
- Williamsburg Middle
- Jefferson Middle
- Kenmore Middle
- Arlington Tech/Career Center)

There were $\mathbf{2 4}$ schools in total with over 100 responses, and these represented $82.8 \%$ of the total responses to the survey.

Students in grades 4-12 responded to the survey. Students in $6^{\text {th }}$ and $7^{\text {th }}$ grade provided 52.1\% of the student responses.
The response rate by grade is provided in figure below. Response rates for grades 4,5 , and 12 were individually under $4 \%$ and collectively represented less than 10 percent of the responses.


Scenario 1 had a slight advantage over Scenario 4 when participants were asked about the scenarios individually. This was the most favored Scenario by parents and staff with 39\% of parents and 32\% of staff supporting implementation of Scenario 1 in 20222023.


## Arlington Public Schools <br> Survey Highlights-Scenario 2



Slightly more than half (51\%) of parents were opposed to the implementation of Scenario 2 in the 2022-2023 academic year. There was little variation in student support across the first four scenarios.

Over half the parents and staff who participated in the survey were in opposition to the implementation of Scenario 3.


Scenario 4 had favorable responses at a rate similar to Scenario 1. Of the parents who participated in the survey, $\mathbf{3 8 \%}$ supported the implementation of Scenario 4 in the 20222023 academic year. Students favored Scenario 4 (25\%) in comparison to Scenario 1 (21\%)


## Arlington

Scenario 5 was the most negatively viewed of the options with over $50 \%$ of each respondent group indicating that they did not support the implementation of this scenario in the 2022-2023 academic year.

## Superintendent's Recommendation

The proposal will standardize times and operate fewer runs allowing greater flexibility for drivers. Elementary runs will be divided among the first and third tiers. Middle will remain at the earlier start time. Instructional time will increase at every level with Career Center remaining at current level.

## Considerations

- Schedule proposal will allow:
- Flexible schedule of routes
- Tier requirements
- $1^{\text {st }}-102$ route runs
- $2^{\text {nd }}-82$ route runs
- $3^{\text {rd }}-92$ route runs
- Ability to address the transportation needs for all countywide programs
- Greater flexibility in meeting extra-curricular and/or sports transportation needs
- Potential cost savings with need for fewer bus drivers and attendants to address route demands.
- 170 drivers- allocation for 194.5 in FY 2023 proposed budget
- 80 attendants- allocation for 94 in FY 2023 proposed budget
