FIRST AMENDMENT TO MEMORANDUM OF LEASE

WHEREAS, on December 6, 2018, Lessee and the Lessor entered into that certain Lease for a Solar Rooftop Photovoltaic System (the "Original Lease") for certain real property as further defined in the Original Lease, amended by that certain First Amendment to Lease Agreement on even date herewith (the "First Amendment" and together with the Original Lease, the "Lease");

WHEREAS, in connection with the Original Lease, Lessee and Lessor executed a Memorandum of Lease dated as of July 21, 2020 and recorded in the land records of the Clerk's Office of the Circuit Court for the County of Arlington, Virginia on August 17, 2020 as Instrument Number 20200100020485 (the "Original Memorandum");

WHEREAS, Lessee has assigned its interests in the Lease to Assignee, with such assignment effective upon mechanical completion of the Facility;

WHEREAS, Lessor, Lessee, and Assignee wish to amend the Original Memorandum, to memorialize the revisions in the First Amendment;

NOW, THEREFORE, the parties hereto do hereby certify and agree as follows:

- 1. Capitalized terms used herein and not otherwise defined shall have the meanings given to them under the Lease.
 - 2. Section 1.2 is hereby replaced in its entirety with:
- "1.2 Term and Consideration. This Lease is in effect from Lease Commencement for a term of twenty-five (25) years at a rate of one dollar (\$1.00) per year."
- 3. This First Amended Memorandum shall run with the Premises and shall be binding upon Lessor, Lessee, and any successor owners of all or any portion of the Premises unless and until this First Amended Memorandum is released from record.
- 4. Other than the terms expressly amended herein, the Original Memorandum remains unchanged and in full force and effect.
