## Dear Parent/Guardian:

Mary Beth Pelosky here, sending you greetings from the Home Instruction Program of the Arlington Public Schools. I hope that this year has been a year of academic and socioemotional growth for your student.

According to state guidelines (Section 22.1-254.1 of the Code of Virginia), the parent who elects to provide home instruction shall provide the division superintendent by **August 1** following the school year in which the child has received home instruction with either (1) evidence that the child has attained a composite score at or above the fourth stanine on any nationally normed standardized achievement test or (2) an evaluation or assessment which the division superintendent determines to indicate that the child is achieving an adequate level of educational growth and progress. <u>Parents/ Guardians of K Learners:</u> This requirement does not apply to children who were under the age of six as of September 30th of the 2022-2023 academic year.

Please send the documentation to meet the above-referenced state requirement to my office no later than **August 1, 2023**.
